GENERAL LIABILITY RELEASE

THIS GENERAL LIABILITY RELEASE ("General Release") is executed by the undersigned individual (referred to herein as the "Participant"), in favor of Gujarati Samaj of Baltimore and all organizers, sponsors, operators and volunteers (collectively referred to herein as the "Releasee") of the Snow Tubing event to be held at SKI Roundtop, 925 Roundtop Road, Lewisberry, PA 17339 on February 13, 2010 (the "Event").

- I have requested permission to participate in the Event. I promise to abide by all rules and regulations or policies of Releasee with respect to participation in the Event, including that I will not undertake any activity that would create a dangerous or unsafe condition for myself or other participants in the Event.
- As consideration for Releasee's permission to participate in the Event, I do fully and finally release, waive, forever discharge and hold harmless the Releasee, from and against any and all liability, damage, claims, demands, actions, causes of action, costs, and expenses of any nature whatsoever that I may suffer or which may hereafter accrue to Participant, arising out of or related to any loss, damage (including property damage), or injury, including but not limited to death, personal injury or personal suffering, that may be sustained by Participant, whether caused by the acts, omissions, or negligence of the Releasee, or otherwise, in connection with the Event.
- I have signed this General Release in full recognition and appreciation of the risks associated with my participation in the Event, which dangers include, but are not limited to personal injury. I agree that I have individually assumed all of the risks involved with my participation in the Event.
- It is my express intent that this General Release shall bind Participant and the members of my family, spouse, estate, heirs, administrators, personal representatives, or assigns, and shall be deemed to be and constitute a "General Liability Release" of the above-named persons or entities. I, the undersigned Participant, further agree to save and hold harmless, indemnify, and defend Releasee (and each of them) from any claim, demand, liability, cause of action, cost, or expense (including, but not limited to, attorneys' fees and expenses of litigation, whether at trial, appeal, or otherwise) by any of the foregoing that is in any way connected with my participation in the Event.
- By signing this General Release, I (the undersigned Participant) acknowledge and represent that I have fully informed myself of the content of this General Release by reading it before signing it, and that I have reviewed it and fully understand that it means that I will have no claim or right to recovery from any named Releasee if I am injured in any way by or related to my participation in the Event (including any disabling personal injury). I sign this General Release voluntarily as my free act and deed. No oral representations, statements, or inducements, apart from the foregoing written statement, have been made to me.
- I further agree that this General Release shall be interpreted and construed in accordance with the laws of the State of New Jersey. If any term or provision of this General Release shall be held illegal, unenforceable, or in conflict with any law governing this General Release the validity of the remaining portions of this General Release shall not be affected thereby.
