



Gujarati Samaj of Baltimore Election for year 2026-2027 Board of Trustees

Rules:

- Mr. Jayesh Jani will be appointed as a President for years 2026 and 2027 according to our bylaws. He will appoint 3 members to the Board of Trustees according to our bylaws.
- The nominating person and the nominee shall be the members of the Gujarati Samaj of Baltimore for the past year (2024) and the current year (2025).
- A member/family cannot nominate a person for more than one position.
- A member can nominate a person for more than one position. If a nominee is elected to more than one position, then the nominee shall select only one position. The other positions will be awarded to the remaining nominees receiving highest number of votes for those positions.
- A member can select nominees for one, more or all positions.
- Members cannot nominate themselves.
- Nomination forms should be mailed to the following address and received by October 31, 2025. Forms mailed to other addresses or hand delivered to any board member will not be accepted.
- Nominating Committee may recommend a slate of candidates for any positions for which no nominations are received.

Election (if necessary) will be held from 10:00 am to 12:00 PM on Sunday, December 13, 2025 at Greater Baltimore Temple, 2909 Bloom Rd, Finksburg, MD 21048. If there is an election, the names of candidates will be posted on our website: gujaratisamajbaltimore.com after November 20, 2025. Members are required to vote in person at the election site. Proxy voting is not allowed.

There will be a General Body Meeting after the elections. Light refreshments will be served.

Jayesh Jani, acting as an Election Officer, will install the new Officers of the Association with the effective date of January 1, 2026.
